#### Terms & Conditions:

- Tata Teleservices Limited and Tata Teleservices Maharashtra Ltd. (hereinafter referred to as TTL) shall bill the Customer as per the billing cycle which shall run on a periodicity as may be decided by the organization from time to time. Taxes shall be as per applicable law.
- All commercial is exclusive of taxes. Port charges per minute per user will be applicable for both Dial in and Dial out - Only the call originator (Host) will be charged for all connected calls Dial-in (Only Port Charges) / Dial-out calls (Port charges plus Call charges). The call originator will be charged for each successfully connected participant. For Domestic Toll free calls, Port charges per minute per user will also be applicable.
- Users login to the bridge will have to pay the local/STD/ISD charges to access the bridge as per the tariff plans opted from respective service providers. No charges will apply to those connections which could not be matured by the conferencing solution. Call charges for each connection will apply only for the duration that the connection was alive in the call on per minute bases.
- This form is meant for use of such applicants who wish to avail of the Conference Call Service provisioned by TTL irrespective of whether or not they are existing TTL customers. By signing this form, the applicant/Customer declares and signifies that he has read and understood these terms and conditions in the context in which they appear and undertakes to be bound by them.
- TTL agrees to provide to the applicant/Customer, the Services, as defined in this Form, subject to these terms and conditions as also those set forth in TTL "Customer Application Form" (CAF), which shall be deemed to form part of this Form and shall be construed and interpreted accordingly.
- The applicant/Customer hereby represents and declares to TTL that the individual(s) signing this Form have been duly and validly authorized to sign the same and that their authority to so sign subsists as on the date of signing of the same.
- The applicant/Customer should intimate TTL regarding any change in the Authorized Signatory(ies).
- In case of existing TTL Customers, the Consolidated Conference Call Charges will be included in the monthly TTL bill separately.
- TTL shall send all bills and notices by courier/post/hand delivery to the address given in serial number 2 of this Form and the Customer shall be deemed to have received the bill/notice at the end of 48 hours from the time when it is delivered by TTL to the courier company/post office/messenger (as the case may be). The Customer shall become liable to pay the bill immediately on its receipt or deemed receipt as above, whichever is earlier. The bill shall be final and conclusive evidence for the amounts due by the customer.
- TTL call charges mentioned above are subject to change, which will be accordingly communicated by TTL or reach us at 1515@tatatel.co.in or call 18002661515 for updated ILD Call Charges
- In case of existing TTL Customers, the payment for the Conference Call Charges is to be effected along with the rest of the payment of the TTL bill.
- In addition to the terms and conditions of this Form and those of CAF, the terms and conditions as mentioned in the billing statement will also govern payments for use of TTL Conference Call Service services.
- TTL reserves the sole right, to refuse any application, at its discretion if the applicant is/has been in default in relation to any payments due to TTL.
- The booking of this service on any occasion is subject to the availability of requisite ports and to the Customer's Account Number, being valid at the desired time of availing the Conference Call Service.
